All stakeholders are supplied with a pre-printed questionnaire to record their opinion. The recorded choices are then processed to obtain the feedback Analysis Report. Feedback from alumni and parents are collected during alumni and parent meetings respectively.

Submission:


The Feedback Analysis Report is forwarded to IQAC for suggestions if any. Finally it is submitted to the College Development Committee (CDC) for its approval.

Action Taken:


Proper suggestions were consolidated to communicate to the Principal and the College Development Committee (CDC) to ensure the proper redressal of the grievances if any.


1. Rate the program that your ward is undergoing in terms of the workload of the courses in different Semesters?




